Item 5: Quarterly Financial Report

March 2025 Financial Status Report-Background

- March represents six (6) months of fiscal year 2025.
- Target represents one-half (1/2) of fiscal year 2025 budget.



March 2025 Financial Status Report -Summary

- Revenue total \$11.0 million or 120% of the target of \$9.2 million.
- Expenses total \$7.2 million or 101% of the target of \$7.2 million.



March 2025 Financial Status Report – Revenue

- Revenue totaled \$11.0 million for the six (6) months or 120% of target.
 - ➤ Wireless revenue totaled 106% of target totaling \$5.9 million.
 - ➤ Landline revenue totaled 89% of target totaling \$665,000.
 - ➤ Interest revenue totaled 307% of target totaling \$460,000.
 - > Other revenue totaled 59% of target totaling \$614,000.
 - ➤ Proposition 8 revenue totaled 200% of target totaling \$3.3 million.



March 2025 Financial Status Report - Expenses

- Expenses totaled \$7.2 million for the six (6) months or 101% of target.
 - > Staff costs totaled \$2.4 million or 82% of target.
 - Below target due to four (4) unfilled full-time staff positions
 - Travel costs are below target. Travel budget decreased in fiscal year 2025. Expenses expected to increase during the fiscal year.
 - Other staff costs are below target. Primarily due to scheduled payments made near the end of the fiscal year.



March 2025 Financial Status Report –Expenses Cont.

- Expenses totaled \$7.2 million for the six (6) months or 101% of target.
 - > Cost of Operations totaled \$4.6 million or 116% of target.
 - Primarily due to nonrecurring costs related to NGCS.
 - ❖ Additional factor include one-time software maintenance payments, software trials, and increased renewal/service costs.
 - Staff are continuing to review costs for possible savings related to future expenditures that would allow expenditures to approach closer to target by yearend.

Note: Despite Cost of Operation expenses ahead of target amounts, total overall expenditures are expected to remain with the approved FY 2025 budget.



March 2025 Financial Status Report – Proposition 8

- Total funding received \$10.4 million.
- Revenue and expenses total \$10.4 million or 100% of total funding.
- Funding accepted at June 2024 Board meeting.
- Funding was fully expended in March 2025.
- The final report to CSEC will be submitted in October 2025.



March 2025 Financial Status Report – NG9-1-1 Grant

- Funding totals \$9.0 million.
- Revenue and expenses total \$7.3 million or 82% of total funding.
- Grant accepted at March 2022 Board meeting.
- Grant continues until December 2026. All funds were obligated by December 2024.
- Fund balance to "back stop" expenses until reimbursed by CSEC (as authorized by Board in FY 2023 Budget).





FIFA 9-1-1 Subcommittee Objectives

- 1. Develop a comprehensive 9-1-1 response plan for the FIFA World Cup 2026
- 2. Establish protocols for handling foreign language emergency calls
- 3. Create procedures for cross-jurisdictional coordination and call transfers
- 4. Identify and implement technology solutions for translation, transcription, and location services
- 5. Coordinate with transportation authorities to integrate road closure and traffic management information
- 6. Develop training programs for 9-1-1 telecommunicators specific to World Cup scenarios
- 7. Create public education materials about emergency services for international visitors

International Number Testing


Outcomes
